



INTERNATIONALLY WHAT IS EXTENDED CARE?

- 1. Formally remaining with foster carers
- 2. Formally remaining with foster carers OR in residential placement
- 3. Formally remaining with foster carers OR in residential placement AND/OR supported accommodation
- 4. Aftercare without necessarily any of the above



PREDOMINANT PLACEMENT TYPE 18-21







ALTERNATIVE APPROACHES

- Later leaving care age
- Completion of education
- Informal private arrangements
- Permanency
- COVID-19 moratoriums

Arguably, there is a received wisdom...that extended care is an important vehicle to facilitate...transitions from care to adulthood and improve outcomes. However...the evidentiary base to support this assertion is thin (van Bred et al., 2020).
